# Health & Social Care Day Opportunities Consultation 2011

## Why do we need to change?

Personalisation is at the heart of our transformation programme. Bristol residents have told us that they want more choice and control over their social care services. Ultimately it means giving people a personal budget where they are given money and can decide what to spend it on to meet their support needs. Whilst our current day services are highly valued, there is a fundamental question as to whether day centres are a model of care that individuals will want to purchase in the future when they manage their own budgets. Our in house day centres are currently operating at an average of 70% capacity.

We also need to ensure that day opportunities provide value for money and are as effective at meeting people's needs as possible.

Bristol is not alone in exploring this issue and many parts of the country are reducing building based services and reinvesting in more flexible community based services.

## What is the council consulting on?

The Council currently provides day services for people with learning difficulties, older people, people with dementia and adults with a disability. Currently there are 801 people who receive these services in specific buildings.

Our starting point would be that we should move away from specific, fixed day “services” to providing day “opportunities”. Our aim is to provide a range of opportunities that meet people's individual need. Day opportunities will : Foster choice and control for individuals; maximise the use of personal budgets; be clear about the outcomes for individuals that the service provides; promote work opportunities for anyone who wants a job; be cost effective.

We want to know what people want from day services and what are important principles. We want to hear a range of views from: people who currently use day centers; people who choose not to; service users who might need day services in the future; carers. We want to hear from older people and people with learning difficulties: the solutions may be different.

In addition we will be looking at: The effect of personalisation on the demand for day opportunities; how to support service users and carers through any change process; consideration of any role that building based services have in the future; consideration of alternative models; consideration of the availability of alternatives; full Equalities Impact Assessment for carers as well as service users.

## How are we consulting?

We have already carried out small discussion groups with a variety of people which has helped us to design our consultation questions.

We will also be speaking directly with service users, carers, groups and organisations representing older people/ people with a learning disability, staff and trade unions to find out their views and opinions.
